GENERAL SESSION MINUTES

1. Call to Order

Board Chairman Steve Turcotte called the meeting to order at 6:05 pm.

The Fire District Board is not permitted to discuss or take action on any item raised in the call to the public. However, individual Board members may be permitted to respond to criticism directed to them. Otherwise, the Board may direct that staff review the matter or that the matter be placed on a future agenda. The Fire District Board cannot discuss or take legal action on any issue raised during the Call to the Public due to restrictions of the Open Meeting Law.
- 6. <u>Proposed 2024/2025 Budget-</u> Approval of FY 2024-2025 Proposal Budget. Board Member Jacquez motion to approve budget, Spieth seconds, motion passes all 3 votes
- 7. <u>Pinal County Financial Resolutions</u>- Motion to approve Jacquez motions to approve, Spieth 2nds it, motion passes all 3 votes.
- 8. Financial Report-The various bank balance's were presented with a discussion on end of year close out.
- 9. <u>Chief's Report</u>- Chief Apodaca discussed a brush fire on June 9th at milepost 118, it was handled as best as it could be with a state truck being in the area they were on scene within 3 minutes, there was a total of 7 agencies on scene to assist, about ½ an acre burned and they were on scene for about 6 hours. Leadership conference July 15-17th. We are still working on the Rescue Truck fixing a/c lines and gaskets older rescue is also being looked at. As well as tuning up the other vehicles. The total incidents for the year is 72.
