## **GENERAL SESSION MINUTES**

- Call to Order
   Board Chairman Steve Turcotte called the meeting to order at 5:30 pm.

Chairman Turcotte opens discussion/review of regular Board Meeting minutes for July 24th meeting. Motion by board member Turcotte, Seconded by Board member Spieth. Motion passes.

Call to the Public.

Consideration and discussion of comments and complaints from the public. Those wishing to address the Pinal Rural Fire Rescue/Medical Board need not request permission in advance but their time is limited to 3 minutes. The Fire District Board is not permitted to discuss or take action on any item raised in the call to the public. However, individual Board members may be permitted to respond to criticism directed to them. Otherwise, the Board may direct that staff review the matter or that the matter be placed on a future agenda. The Fire District Board cannot discuss or take legal action on any issue raised during the Call to the Public due to restrictions of the Open Meeting Law.

- 6. <u>Financial Report</u> Chairman Turcotte discussed the various bank account balances. He reported that we collected about 20% of our tax revenue. Budget execution is on track.
- 7. Chief's Report- Chief Apodaca discussed Fire school Sept 6-11<sup>th</sup> four firefighters attended, 2 attended Crisis Support, 1 attended Rescue to Natural Gas training and incident 1 attended Safety Officer training. Chief Apodaca also addressed issues with water South of the tracks that effects about 6 residents and that we have been in assistance with them helping them get water as well as the community and Pinal County, with hopes of it being fixed within the next month. More grants are being looked into and Pinal Rural will be assisting with traffic control for the Gold Bond Mine who will be doing some blasting in the area.
