The Fire District Board cannot discuss or take legal action on any issue raised during the Call to the Public due to restrictions of the Open Meeting Law.

Chairman Turcotte discussed the 2023/2024 budget. The State has initiated a new form for the Annual budget. It now includes 3 years of data. Our budget is very similar to their form and will be easily adapted. He then discussed the various bank balances.
